AGREEMENT FOR TENNIS SECTION SPONSORSHIP

The following sponsorship options are available (all prices inclusive of VAT).

1. Website sponsorship - £48 per annum, payable in advance for display of Corporate logo on the website homepage, and then on each subsequent anniversary date of the Agreement date
2. Website sponsorship - £120 for three years from the Agreement date, payable in advance for display of Corporate logo on the website homepage
3. Windbreak sponsorship - £252 per annum, payable in advance, for display of windbreak with printed corporate name/logo, and then on each subsequent anniversary date of the Agreement date
4. Windbreak sponsorship - £610 for three years from the Agreement date, payable in advance for display of windbreak with printed corporate name/logo
5. Windbreak and Website sponsorship - £288 per annum, payable in advance for display of Corporate logo on the website homepage and for display of windbreak with printed corporate name/logo, and then on each subsequent anniversary date of the Agreement date
6. Windbreak and Website sponsorship - £720 for three years from the Agreement date, payable in advance for display of Corporate logo on the website homepage and for display of windbreak with printed corporate name/logo

- Wombourne Cricket, Tennis & Bowling Club ("the Club") retains ownership and responsibility of each sponsored windbreak.
- The Sponsor will provide the Club with a pdf file (or other format as requested) of the Corporate name/logo to be printed on each windbreak and/or to be displayed on the website homepage.
- The Club reserves the right to remove the windbreak if sponsorship renewal fees are not received, or during periods of general ground and court maintenance.
- The Club reserves the right to remove the sponsor's name/logo from the website if sponsorship renewal fees are not received, or during periods of general site maintenance.
- The Club reserves the right to manage the colour of printing to ensure consistency with other windbreaks.
- Renewal fees shall become payable on the anniversary date of the agreement date.
- A 10% discount will be applied to each additional windbreak purchased.
- The agreement date will commence from the date the procured windbreak is displayed, or logo displayed on the website, or the date of the later event if both sponsorship options are procured.
